### ONE OFF GIFT AID DECLARATION

As a supporter of Sewa International, you will know how hard we work to ensure that every penny we raise goes as far as it can for National Sewa Day. Through Gift Aid and Transitional Relief, you can help us make your donations go 28% further and it won't cost you a penny!

### HOW DOES IT WORK?

So long as you are a UK taxpayer, Gift Aid enables you to boost the value of your donations by 28p for every £1 you give (25p in Gift Aid and a further 3p in Transitional Relief) to your favourite charity.
